



# United in Song Choral Festival, Tallinn (Estonia)

June 28-July 3, 2022

Frequently Asked Questions - Answers valid as of September 20, 2021

## Are U.S. citizens allowed to travel to Estonia?

Yes.

## Do visitors from the U.S. need to be vaccinated to enter Estonia?

Yes. The current regulations permit vaccinated travelers who can present either a U.S. Centers for Disease Control (CDC) paper vaccine certificate, a digital EU certificate (either on an electronic smart device or printed), or a vaccination certificate issued in the EU, the EEA countries, Switzerland, or the United Kingdom to enter Estonia.

## What other COVID related entry requirements does Estonia have?

All passengers arriving in Estonia by plane (including children for whom the data is provided by their parent) must complete a declaration of health before arriving in Estonia. The declaration of health can be completed electronically starting three days before arriving in Estonia.

## Do visitors need to quarantine for any length of time?

No, but they are required to be fully vaccinated with a vaccine accepted by the European Union before entering Estonia (e.g. Moderna, Pfizer/BioNTech, Johnson & Johnson).

## Do we have to wear masks in Estonia?

Masks are required in indoor spaces that do not require the vaccination certificate (e.g. post offices, shopping centers, banks, public transportation, all coach transfers during the "United in Song" choral festival, etc.). Restaurants, cafes, music & sports venues, museums, and attractions require visitors to show proof of vaccination to permit entry.

## Do we have to wear masks while we sing at the Estonia Concert Hall?

Audience members must present a vaccine passport (proof of vaccination) or negative test result together with a valid identity document (ID card, driver's license, passport) in order to enter the concert hall. Documents will be checked upon entering the venue. The inspection is performed by the owner of the hall. The same Government rules apply to performers. The concert organizer is responsible to check that all performers fulfill these requirements (proof of vaccination). Today's rules do not require performers to wear masks while singing. Audience members are not required to wear masks either.

## What are the COVID testing requirements to return to the U.S.?

The U.S. requires that all persons (U.S. citizens, green card holders, and foreign visitors) get a viral test no more than 3 days before travelling by air into the United States and show the negative result to the airline before boarding the flight. Without such a test passengers will be denied boarding by the airline.

## What if I get COVID in Estonia and can't return?

Passengers are not able to enter the U.S. without a negative viral test. If you contract COVID in Estonia you will be required to quarantine in Estonia until you can show a negative test result. The cost for the quarantine stay (e.g. accommodation, meals, transportation, testing and medical costs, etc.) are the responsibility of the passenger. Travel Insurance might cover some of those costs.

### **What if I contract Covid before the tour starts and cannot travel?**

The cancellation and refund policy as per the terms and conditions of the tour will apply. Most Travel Insurance policies will cover such instances. Perform International recommends travel insurance to help cover trip cancellation/interruption, travel delay, emergency medical, baggage delay and accidental death coverage.

### **What is the vaccination rate in Estonia?**

As of Sept. 18, 2021 44.3% of the population of Estonia has received two vaccine doses and 56.5% have received at least one dose.
